Students who are attending a seminar during this first semester (academic year 2017-2018) will see the seminar directly on the exams' transcript.

Students who want to attend one between **prof. Barone's seminars (Algorithmic Trading and Rotman Trading Lab)** which take place every year during the first semester, will be allowed to **select it in the Web Self-Service in June 2018, in order to attend it in academic year 2018-2019.**

From 22nd to 29th November 2017, the Web Self-Service will only allow you to select seminars held during the second semester of this academic year 2017-2018.

N.B.: The attendance at the seminars will not give you credits useful to the achievement of the Master's Degree.

 - Always check if the system registered your last choice correctly** by entering more times in the system. You can do it until November 29th.
